Investment Horizon: 5 years

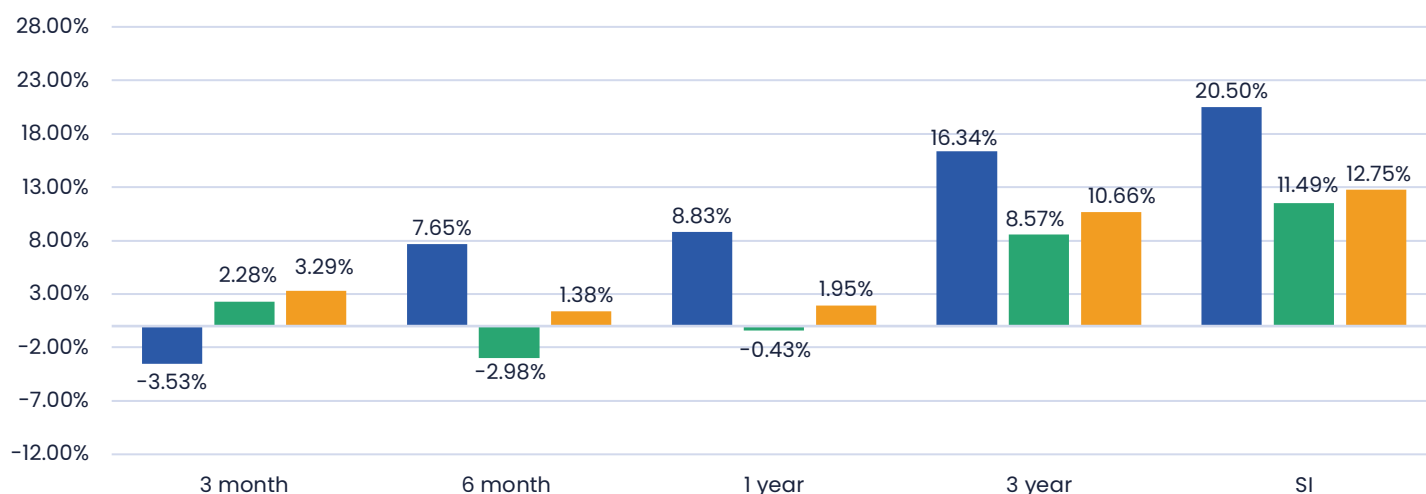

■ BONANZA AEGIS ■ NIFTY 50 TRI % ■ BSE 500 %

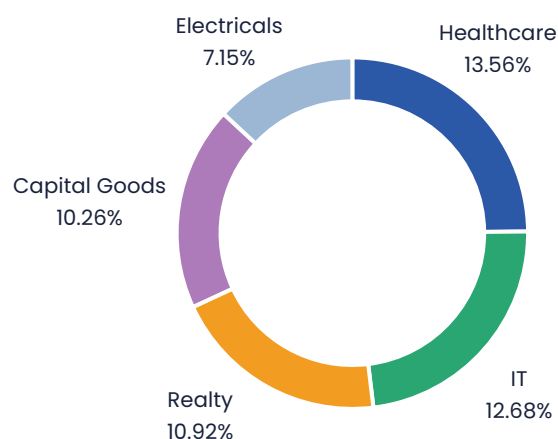
