Strategy Name: Pulse Sector Strategy

Investment Objective:

The Bonanza Pulse Portfolio follows a disciplined investment approach focused on identifying sectors with the potential to outperform the broader market. Since market leadership is typically limited to a few sectors at any given time, the strategy aims to capture these opportunities using a combination of technical indicators, relative strength, and fundamental validation, with emphasis on sector rotation and selective stock picking.

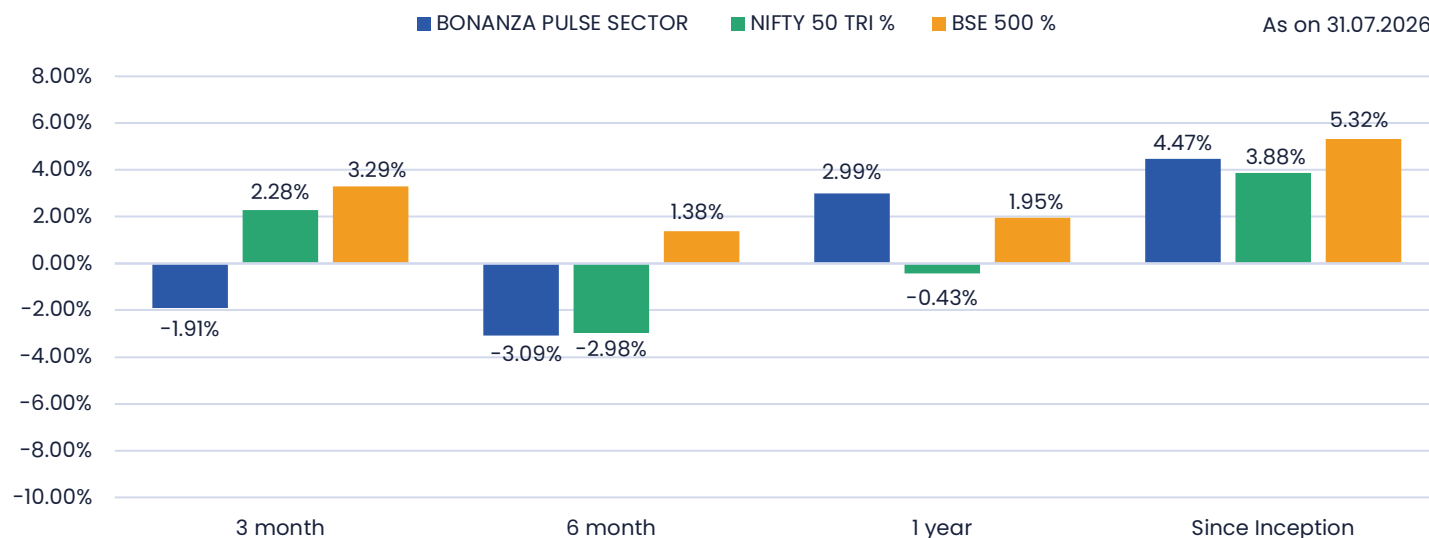

KEY FEATURES & PORTFOLIO ATTRIBUTES

- Actively managed portfolio with flexibility to realign investments based on changing market conditions.
- Focus on stocks showing strong price trends and momentum, supported by sound business fundamentals.
- Investment decisions are primarily driven by technical analysis, with fundamentals used as a validation tool.
- Clearly defined risk management framework with a fixed stop-loss of 15% per stock.
- Exposure to any single stock is limited to 5% of the portfolio to manage concentration risk.
- Sector allocation is capped at 20–25%, ensuring diversification while capturing sector-specific opportunities.

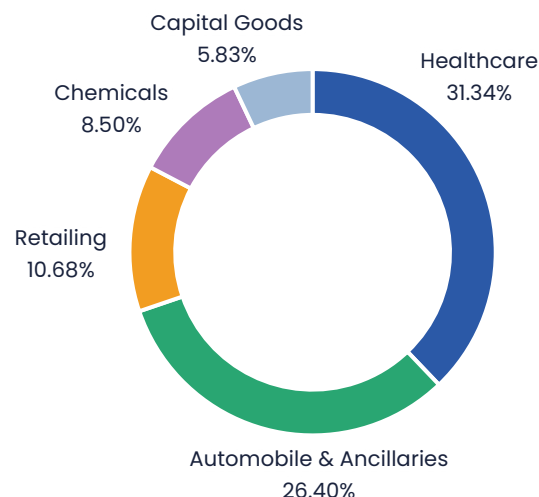
STRATEGY PERFORMANCE SINCE INCEPTION Vs BENCHMARK*
