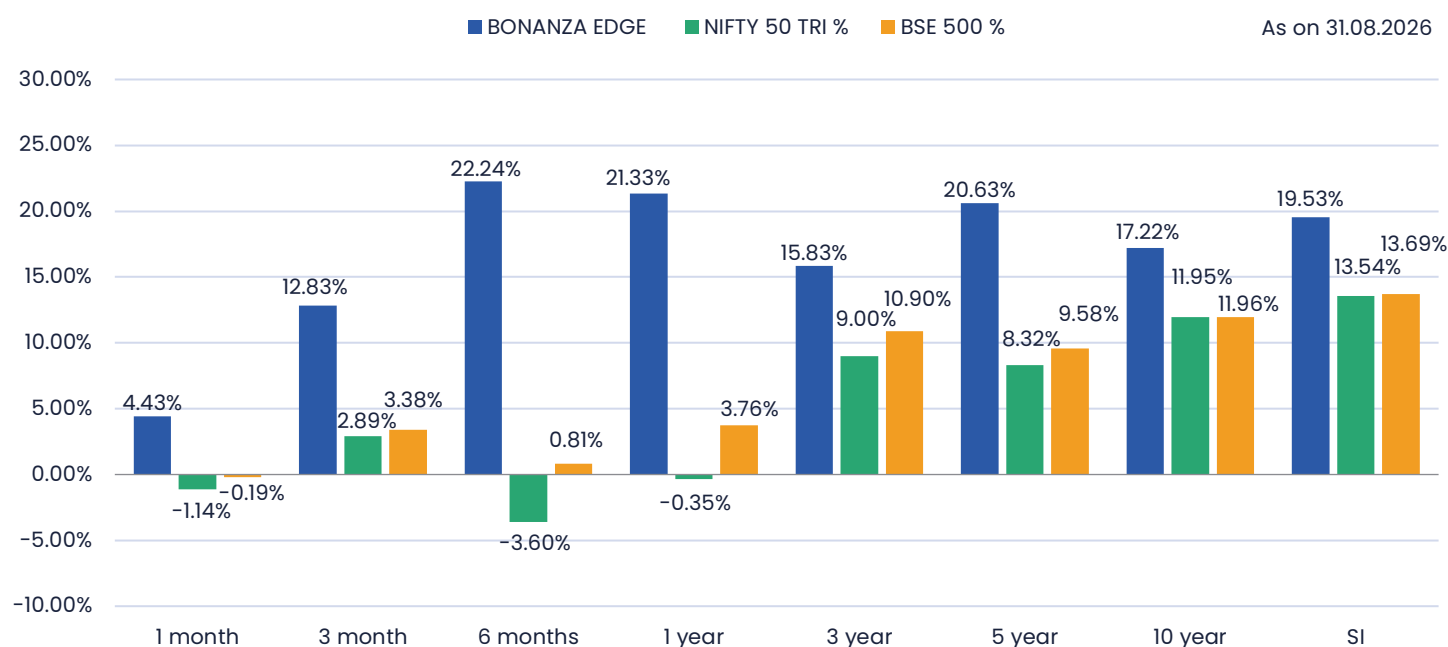

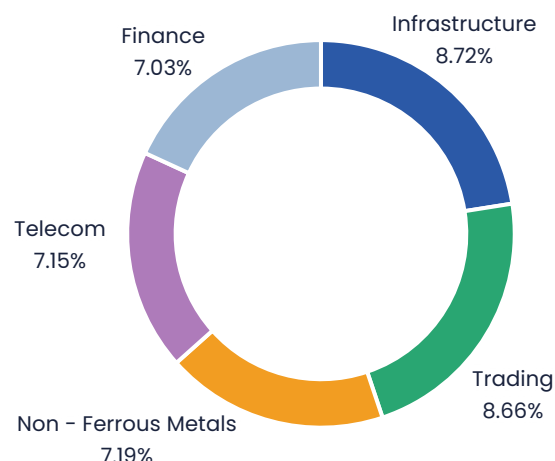
STRATEGY PERFORMANCE SINCE INCEPTION Vs BENCHMARK*
